Quotations are hereby invited for Provision for Evaluation of Landfill Sites.

Quotation documents can be obtained at Koukamma Local Municipality, Supply Chain Management offices at 5 Keet Street, Kareedouw 6400. Fully completed quotation documents must be placed in a sealed envelope and placed in the tender box next to the security at the main entrance of Koukamma Local Municipality at 5 Keet Street, Kareedouw 6400 by not later than 12:00 on Friday, 14 July 2023. The envelopes must be endorsed clearly with the number, title and closing date of the tender as above.

Quotation will be evaluated on the 80/20 Preference Points system as prescribed by the Preferential Procurement Regulations of 2022, 80 for price and 20 in terms of the Municipality's specific goals as clearly outlined in the tender document and in the SCM policy of Koukamma Local Municipality that can be found at www.koukammamunicipality.gov.za. Bidders are required to submit a detailed CSD report with ID copies of entity's directors to earn points on Specific Goals. *The guidelines for locally produced goods or locally manufactured goods with a stipulated minimum threshold where applicable will be applied.*

The tender box will be emptied just after 12:00 on the closing date, hereafter all quotations will be opened in public. Late quotations or quotations submitted by e-mail or fax will under no circumstances be accepted. The Municipality reserves the right to withdraw any request for quotation and/or to re-advertise or to reject any quotation or to accept a part of it. The Municipality does not bind itself to accepting the lowest quotation or approve a quotation to the bidder scoring the highest number of points.

Minimum Bid Requirements:

- The bidder must have at least 2 successful completed projects of similar nature.
- The bidder must have at least 1 Practitioner with at least 2 years of experience + NQF level 6 qualification.

NB: No tenders will be considered from persons in the service of the state.

Bidders must also attach their Tax Clearance Certificate, Municipal Billing Clearance, or a valid Lease Agreement, Detailed CSD Report, Company Registration Certificates, Certificate of Signatory, the bidder must comply with all bid requirements as appears in the bidding documents and the tender documents must be filed and signed in full.
